CANCELLATION OF THE PROCUREMENT PROCEDURE

CONSULTING SERVICES FOR THE PRODUCTION AND ESTABLISHMENT OF THE CARTOGRAPHIC DATABASE FOR THE SCALE OF 1:100.000 AND PRODUCTION OF THE TM100 PRODUCT SPECIFICATIONS

(CONSULTING SERVICES – FIRMS SELECTION – Ref. No.: SGA/ILAS-B4-2b/CQ/15/88R)

Integrated Land Administration System Project (hereinafter referred to as: „ILAS Project“) was initiated by the Government of the Republic of Croatia with the aim of modernization of the land administration system in order to improve on the civil service from the point of view of efficiency, transparency and cost. It is under the competence and equal implementation of the Croatian Ministry of Justice (hereinafter referred to as: „MOJ“) and the State Geodetic Administration (hereinafter referred to as: „SGA“). The ILAS Project is financed by a World Bank loan (hereinafter referred to as: „Bank“) and Croatian State Budget.

The Purchaser (MOJ and SGA) intended to use part of the Loan proceeds for financing costs of CONSULTING SERVICES FOR THE PRODUCTION AND ESTABLISHMENT OF THE CARTOGRAPHIC DATABASE FOR THE SCALE OF 1:100.000 AND PRODUCTION OF THE TM100 PRODUCT SPECIFICATIONS, as stipulated in the Request for Expression of Interest, published in Official Gazette No.74 on 12.08.2016., on the web pages of the ILAS Project and web pages of the State Geodetic Administration.

The procedure was conducted in line with World Bank’s Guidelines: “Selection and Employment of Consultants under IBRD Loans and IDA Credits and Grants by World Bank Borrowers” (published in January 2011) (“Consultant Guidelines”) and was open to all eligible candidates as defined in the Guidelines.
